<u>Minutes:</u> O'Leary motioned to approve the February 10, 2015 minutes as presented. Second by Mathews. Motion passed.

Audit of Current Bills:

Town Fund - Upon completion of discussion of the proposed 2015-2016 Town Fund Budget, O'Leary motioned to display the budget for thirty (30) days prior to the Budget Hearing scheduled for 6:15 p.m. April 14, 2015. Second by Dahlfors. Motion passed.

Road District - Mathews motioned to table the Road District Budget discussion and display until the April Regular Monthly Meeting due to revisions needed to be made. Second by Dahlfors. Motion passed.

- **B.** Approve agenda for Annual Town Meeting April 14, 2015: O'Leary motioned to approve, publish, and display the Annual Town Meeting Agenda as presented. Second by Dahlfors. Motion passed.
- C. Approve schedule for meeting dates April 1, 2015 through March 31, 2016 to be posted by April 1, 2015: Upon conclusion of discussion, O'Leary motioned to set the Regular Monthly Meetings for the 2nd Tuesday of each month to begin at 6:30 p.m. Second by Dahlfors. Motion passed with a 3-2 vote.
- **D.** Highway Commissioner's annual report presented to the board: Dahlfors motioned to approve the Highway Commissioner's Annual Report as presented. Second by Mathews. Motion passed.
- E. Approve line item transfers for Town Fund and Road District Funds: Town Fund -
 - \$200.00 transferred from line item 1435 (misc. in Assessor Budget) to line item 1405 (office supplies)
 - \$200.00 transferred from line item 1305 (contractual services) to line item 1360 (postage)

Dahlfors motioned to approve the above Town Fund line item transfers. Second by Bartman. Voting yes: Bartman, Mathews, Dahlfors, O'Leary, Kagel. Voting no: None. Motion passed.

Road District -

- \$2,897.52 transferred from line item 3440 (road & bridge fund contingencies) to line item 3405 (fuel)
- \$25.28 transferred from line item 3440 (road & bridge fund contingencies) to line item 3167 (training)
- \$2,661.16 transferred from line item 4420 (permanent hard road contingencies) to line item 4424 (trucks & equipment)

Mathews motioned to approve the above line item transfers. Second by Dahlfors. Voting yes: Bartman, Mathews, Dahlfors, O'Leary, Kagel. Voting no: None. Motion passed.

Supervisor's Report:

- Kagel received an invoice for a \$250 donation for the McHenry County Historical Society.
- A resident called inquiring about using the town hall building.
- Kagel wrote a letter to TOI (Township Officials of Illinois) in response to a Northwest Herald article regarding a Supervisor in another township who never did an audit in twenty (20) years, that now can't be audited due to the shape the records are in. TOI has responded back to him.
