Second by O'Leary. Motion passed
- **G.** Consideration of TOI Drug Discount Card Program Kagel received information from Township Officials of Illinois regarding a Drug Discount Card program for Seneca Township residents through CVS Pharmacy Caremark. Mathews motioned that we are interested, but without commitment, in the Card Program, and would like further information as to how it works. Second by Dahlfors. Motion passed.

Supervisor's Report:

- Kagel informed the board that our U.S. and Illinois Flags are tattered and will be replacing them.
- The McHenry County Map that we discussed and ordered at a previous meeting has arrived.

- Kagel learned that next year's payroll software is not compatible with QuickBooks 2009, which we currently run, and will need to upgrade to QuickBooks 2012. The approximate cost for a complete upgrade is \$400.
