3. Transfer \$700 from line item 1435 (Misc. (Assessor's Budget)) to line item 1405 (Office Supplies). Semro motioned to approve this transfer. Second by Mathews. Voting yes, Bartman, Mathews, Semro, Gerloff, Kagel. Voting no: None. Motion passed.

4. Transfer \$100 from line item 1370 (Travel Expense) to line item 1375 (Publications). Bartman motioned to approve this transfer. Second by Mathews. Voting yes, Bartman, Mathews, Semro, Gerloff, Kagel. Voting no: None. Motion passed.
