<u>Minutes:</u> Dahlfors motioned to approve the April 14, 2015 regular monthly minutes as presented. Second by Bartman. Motion passed.

<u>General Assistance Report:</u> Kagel informed the board that he went to a General Assistance training meeting, for which he felt was not worth his time. With that being the case, we could presumably automatically deny the medical part of General Assistance. Kagel will look into this further.

<u>Clerk's Report:</u> Seemann reported she has looked into website providers and will keep the board updated to her progress.

**Road Commissioner's Report:** Swanson reported he has been doing general road maintenance this month. In addition, he has a FWD for sale as mentioned at last month's meeting. He wants to purchase a used 1998 dump truck with a plow and spreader from Greenwood Township.

-Swanson also stated that some Road Commissioners went to Springfield and met with state representatives. They were told townships need to make a drastic cut or they will "run right over us."

<u>Assessor's Report:</u> Bockman informed the board that he has been measuring and assessing properties, doing field checks, etc. and reviewing various issues for the county.

- Bockman will be going to Springfield for some Department of Revenue classes.

<u>Supervisor's Report:</u> Kagel received some Township Consolidation information compiled by various supporters of consolidation that he passed on to the board for their records.
