<u>General Assistance Report:</u> Kagel reported he received one call today for assistance. He mailed the person an application.

<u>Clerk's Report:</u> Seemann has nothing to report this month.

Road Commissioner's Report: Swanson reported the 1st mowing of the right-of-ways is complete. In addition, they have been changing out culverts and performing regular maintenance on the equipment. Swanson informed the board that he finally received the salt bill and paid it this month. It had previously been sent multiple times to a P.O. box which has no connection to Seneca Township.

<u>Assessor's Report:</u> Bockman stated he has turned the assessment books into the county. In addition, he has been helping seniors do their senior freeze forms.

New Business:

A. Review and possible action on request for conditional use permit 2014-009 PIN 12-09-300-006 (DeSerto-Jozwiak) - The Seneca Township Planning Commission met and reviewed the petition, in which the petitioners are asking for a Conditional Use Permit (CUP) for the operation of a sawmill; storage of commercial vehicles and equipment; and woodworking and production of furniture on the

premises. The Planning Commission ultimately voted to recommend denial of the Conditional Use Permit. Upon the Seneca Township Board's review and discussion of the CUP, Dahlfors motioned to deny the CUP and request Kagel to notify the McHenry County Zoning Board of Appeals of the denial based on under the A-1 Zoning rules: 1) Furniture Sales are not allowed, and 2) Manufacturing is not permitted in this type of zoning district. Second by O'Leary. Motion passed.

B. Vote on INTENT TO COMPLY with the Prevailing Wage Ordinance - Dahlfors motioned to approve the intent to comply with the Prevailing Wage Ordinance for the Town and Road District. Second by Mathews. Voting yes: Bartman, Mathews, Dahlfors, Kagel. Voting no: O'Leary. Motion passed.

<u>Supervisor's Report:</u> Kagel confirmed that he and Bartman will be attending the TOI training, and will mail the application.

<u>Motion to Adjourn:</u> At 7:34 p.m. Dahlfors motioned to adjourn tonight's regular monthly meeting. Second by O'Leary. Motion passed.
