<u>Minutes:</u> Dahlfors motioned to approve the February 11, 2014 regular monthly minutes as presented. Second by Bartman. Motion passed.

<u>Assessor's Report:</u> Bockman stated he want to get the PAMS information online and have a website built. Seemann will get him the contact information for the township website.

- In addition, Bockman informed the board that the drawings and pictures for the major subdivisions are finished and linked. He will be working on the remaining subdivisions soon.
- Thirty permits need to be revisited.
- One new construction permit has been obtained so far this year.

New Business:

- A. Review 2014-2015 Town and Road District budgets and recommend public posting for 30 days prior to hearing [set time and date] and approval Kagel informed the board that the Budget Hearings won't be able to be approved at the Annual Town Meeting due to not having it displayed for 30 days prior to the Town Meeting because of the date the meeting falls on. Therefore, the *Budget Hearings will take place during the May 13, 2014 meeting at 6:50 p.m.* Seemann will publish the hearing budget in the newspaper.
- **Road District Budget** After review of the proposed 2014-2015 Road District Budget, Dahlfors motioned to put it on display for 30 days prior to the May 13, 2014 hearing scheduled to take place at 6:50 p.m. Second by Mathews. Motion passed.
- **Town Fund Budget** Upon review of the proposed 2014-2015 Town Fund Budget, the board decided it was necessary to revise the Assessor portion of the budget by adding \$1000.00 to the Capital Outlay. Dahlfors motioned to put the proposed 2014-2015 Town Fund Budget, with the \$1000.00 addition to the Assessor's budget, on display for 30 days prior to the May 13, 2014 hearing scheduled to take place at 6:55 p.m. Second by Mathews. Motion passed.

- **D.** Approve schedule for meeting dates April 1, 2014 through March 31, 2015 to be posted by April 1, 2014 Upon the conclusion of discussion, Bartman motioned to change the regular monthly meeting times from 7:00 p.m. to 6:30 p.m. starting at the May 2014 meeting. Second by Dahlfors. Motion passed.
- **E. Highway Commissioner's annual report presented to the board** O'Leary motioned to approve the Swanson's Annual Building and Equipment Fund Report, as presented. Second by Dahlfors. Motion passed.
- **F.** Appoint person for second signature on tax distribution to bank accounts Dahlfors appointed Bartman to be the second signature as needed on tax distribution to bank accounts. Second by O'Leary. Motion passed.

<u>Supervisor's Report</u>: Kagel informed the board that he has finally resolved the issue with the Assessor's phone bill and has successfully had it reduced.
