## New Business:

A. Present 2019-2020 Town and Road District Budgets to board for approval to post 30 days prior to budget hearing and adoption:

- Road District: Swanson informed the board that his budget has not changed much from last year. It is slightly more than last year. Mathews motioned to put the 2019-20 Road District budget on display for 30 days prior to the Budget Hearing and adoption in May. Second by Gieseke. Motion passed.
- Town Fund: Kagel informed the board that due to cutting back on the Levy, the working cash fund is approximately $\$ 5,000$ less than last year. Minor changes were made to this year's budget compared to last year's. Mathews motioned to put the 2019-20 Town Fund budget on display for 30 days prior to the Budget Hearing and adoption in May. Second by Bartman. Motion passed.

Supervisor's Report: Swanson presented the board Budget vs. Actual Reports for their records.

Adjourn: At 7:11 pm Mathews motioned to adjourn tonight's regular monthly meeting. Second by Bartman. Motion passed.
