<u>Assessor's Report:</u> Benitez is absent from tonight's meeting, but left her report with Supervisor Brown. Benitez reported her prep for appeals is complete. Appeal hearings and non-hearings are in the process and will continue through November. She is continuing to input sales and permits, along with site visits.

## **New Business:**

- A. Determine amount of tax levy for tax year 2022 collectible in 2023, for road district and town funds, and make publicly available for review prior to adopting at the December meeting -
- **Town Fund Levy** no change from last year. No increase or decrease.
- Road District 4% increase from last year's levy due to increase in fuel prices.

The Town Fund and Road District levies will be on display at the Seneca Township Building until the December meeting.

**B.** Not on the agenda - Bartman suggested a new sign is needed for the next election due to now having 3 precincts. Currently, there is signage for only precinct 1 and 2. Brown said he will make a new sign with all 3 precincts listed on it.
