Assessor's Report: Assessor Benitez is absent tonight, but left her report with Supervisor Brown. Benitez reported she continues doing tasks throughout the year including data entry of sale and permits. Answering calls and emails from taxpayers, appraisers and other inquiring individuals, and continues to do sales ratio studies. When weather permits, she is continuing updates which include site visits for permits, home exemption status, and updating the property record cards. The Appeals for 2024 were down-only two for this year. Benitiez would like to remind everyone to check their exemptions on their assessment notice or tax bill to make sure they have the exemptions they are entitled to-especially the Senior Homestead Exemption for those over 65.
